Enjoy the stark beauty of craggy rock outcroppings, rolling vistas and bubbling streams as you make your way to this unique offering rarely found on the market in this recreational haven in scenic eastern Oregon! This holding offers almost 1/3 mile of river frontage and fabulous views of the valley.

This immaculate 3800 sq. ft. home has been remodeled and upgraded with knotty pine, wood and tile flooring with a rock wall accenting its open design. It has four carpeted bedrooms and 3 bathrooms. Upon entry there is a large dining area with wood stove and spacious kitchen, island, plenty of windows, cupboard and counter space, double ovens, built in range top, dishwasher and refrigerator. Natural and overhead lighting compliment this relaxing atmosphere.

The living area is room of many views and boasts a wall of windows that overlook the river and this pristine valley ... doors that take you outside to the large wrap around deck with benches and patio, perfect for entertaining or just enjoying the solitude overlooking this beautiful setting on 20 acres.

Lower level features concrete daylight basement with 2 bedrooms, one bathroom, family room, utility/laundry room with sink, pantry, storage/work area with plenty of shelving and room for extra freezers. Also included is a 36'x40' attached carport, and a 36x27 detached garage/shop combo with concrete floor.

The cozy 864 sq. ft. cabin has been tastefully decorated with oak and maple flooring, tile counters in the full kitchen, living area with wood/electric heat, and 1 bathroom and 1 bedroom that sits along the river below the main house. A few acres of water rights irrigate the fenced garden and the nicely shaded lawn area. A private well services both dwellings for domestic use.

If you are seeking a quiet, well situated recreational getaway or full time residence in one of the most

desirable locations in eastern Oregon, this offers an amazing variety of sporting options for the outdoor enthusiast. The John Day River boasts some of the best fishing for bass, steel head and river rafting at its finest right out the front door. Big game hunting & more recreation are within close proximity.

Twickenham is an unincorporated community in Wheeler County, in the U.S. state of Oregon. It is located along the John Day River between Service Creek and Mitchell, Oregon. A bridge at Twickenham carries North Twickenham Road over the river.

The locality was originally named Contention after a quarrel between two of its prominent residents. The Contention post office opened in 1886. A daughter of one of the residents involved in the quarrel suggested that the name Twickenham, after the London suburb in England, would be more dignified than Contention. As it happened, the Contention post office closed in 1895, and a Twickenham post office opened in 1896 in the same general vicinity. It closed in 1917, and mail to Twickenham thereafter has been sent via Fossil, about 20 miles (32 km) to the north.

After formation of Wheeler County in 1899, Twickenham was suggested as a possible county seat. A county-wide election held in 1900 produced 436 votes for Fossil, 267 for Twickenham, and 82 for Spray. At the time, Twickenham had a store, hotel, blacksmith shop, and a ferry across the river.
